EU Regulation 1907/2006 (REACH) Compliance

The Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) regulation (EC) No 1907/2006 is a European Union chemicals regulation that entered into force on 1 June 2007.

Substances in Articles

Article 33 of REACH requires information to be communicated down the supply chain on Candidate List substances of very high concern present within articles at a level exceeding 0.1%w/w. The Candidate List is maintained by the European Chemical Agency and can be found [here](#).

VIAVI is a supplier of very complex objects containing components that are both articles and complex objects made from articles. The following Candidate List substances are present within certain types of VIAVI product components.

Registration of Substances

Articles 6, 7, 21 and 23, require substances on their own, in preparations or in articles to be registered before being placed on the market.

The VIAVI Optical Security and Performance Products Group has established an “only representative” in the European Community and has completed the necessary preregistration process in the event its products are classified as preparations rather than articles. This will ensure an uninterrupted supply of products to our European customers.
